- **There is a \$100 application fee that is due with your application.**
- **Your application will be submitted at the next Board of Directors meeting. After BOD approval, our general membership then has 10 days to object.**
- **You are invited to continue to attend meetings until your membership is approved.**
- **Dues are \$345 annually and pro-rated to the month you join. You will receive an email and invoice when you become a member. Our fiscal year is July 1 – June 30. Dues will be due again prior to July 1.**
- **Meetings are weekly at the Century Center from Noon - 1:00 pm.**
- **You must either buy a beverage for \$4 or lunch for \$15. We take cash and credit cards.**
- **You can expect to spend upwards of \$600 a year being a Rotarian.**
- **There will be many chances to donate time and/or money to great causes! Generally, Rotarians invest about \$600 a year to support local, district or Global Rotary efforts of Rotary.**
